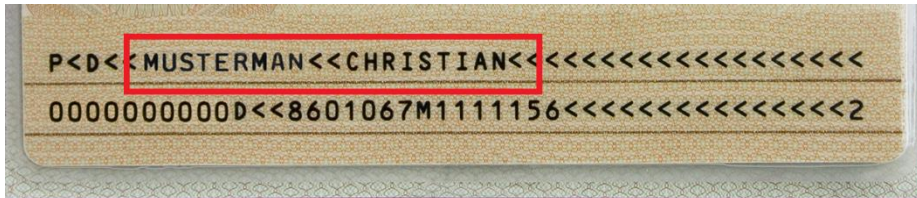

COURSE SELECTION

Course Selection and Registration

IEC highly recommends to select desired courses before an application to check if the university is a good choice (study focus, transferring grades/courses back home). If the course catalog for the desired semester is not yet available, check the same semester of the year before (most courses are repeated on a yearly basis!). Bachelor students are required to take 12 US credits (usu. 4 courses), Master students 9 US credits (usu. 3 courses) by F-1 visa requirements. It is highly recommended to select additional alternative courses (to avoid time clashes etc.).

As soon as the HPU course schedule is available online (www.hpu.edu/courses), you may select courses and submit your list to your admissions coordinator, if you have not already done so upon applying. An HPU advisor will review your course selection to ensure that the selected courses meet your needs and interests. HPU will also look at your transcripts to determine if you have the appropriate background knowledge for the HPU classes you have chosen and that all prerequisites have been met. If no further information is needed, you will be registered and contacted via e-mail to inform you about your course registration.

Additional information on course selection (coming into effect for Spring 2022) as a result of numerous course changes among international visiting students in Fall 2021 semester: reasons cited by students were that courses were either not what they expected or covered materials that they did not feel prepared for. Therefore, by providing "level-setting" knowledge earlier on in the course registration process, HPU intends to set the right expectation about the content of the course. The ultimate goal is to help students make better initial course selections from the outset.

Explanation of the expectations based on the prerequisite "language" that is included on the course lists for Spring 2022 semester:

Prior college-level writing course: students should expect a reading and writing intensive course (in English).

Prior general X course required: students should expect to have a general knowledge of the topic and course expectations will assume that this general knowledge has been covered.



X-majors only: students should expect that significant experience in the topic is required and the student should be a declared major in the same field at their home university. Please note that registration is dependent upon course availability and their attestation of meeting any course requirements/prerequisites.
